Overview of this report

The Pyramid Model State Leadership Team Data and Evaluation Workgroup developed a **Family Engagement Survey** to collect data that it hoped would inform the State's and individual programs' improvement efforts.

On 3/4/24 the Family Engagement Survey was emailed to 40 NH child care programs on the Granite Steps for Quality Pyramid Model Pathway. These Program Directors were asked to share the survey with families by 3/15/24; completed surveys were to be submitted by 3/29/24.


Survey respondents were asked to rate their level of agreement with 14 statements related to Pyramid Model priorities: Communication with Families; Social Emotional Support; Support for Behavior Challenges; Sharing Data and Information; and Pyramid Model Implementation. In addition to these 14 multiple-choice ratings, respondents had an opportunity to share narrative comments about each of the above-named priorities.

There were a total of 212 responses from 19 child care programs. The number of survey responses per site ranged from 2 to 28.

This presentation summarizes the ratings across ALL 212 respondents.


Each participating site that had more than 3 respondents (to protect confidentiality) received detailed results specific to their program. Site level reports included the narrative comments as well as the multiple-choice ratings.
